## REGULATIONS

of USMMAF and Unifight Open Championships

29 - 31, May 2020

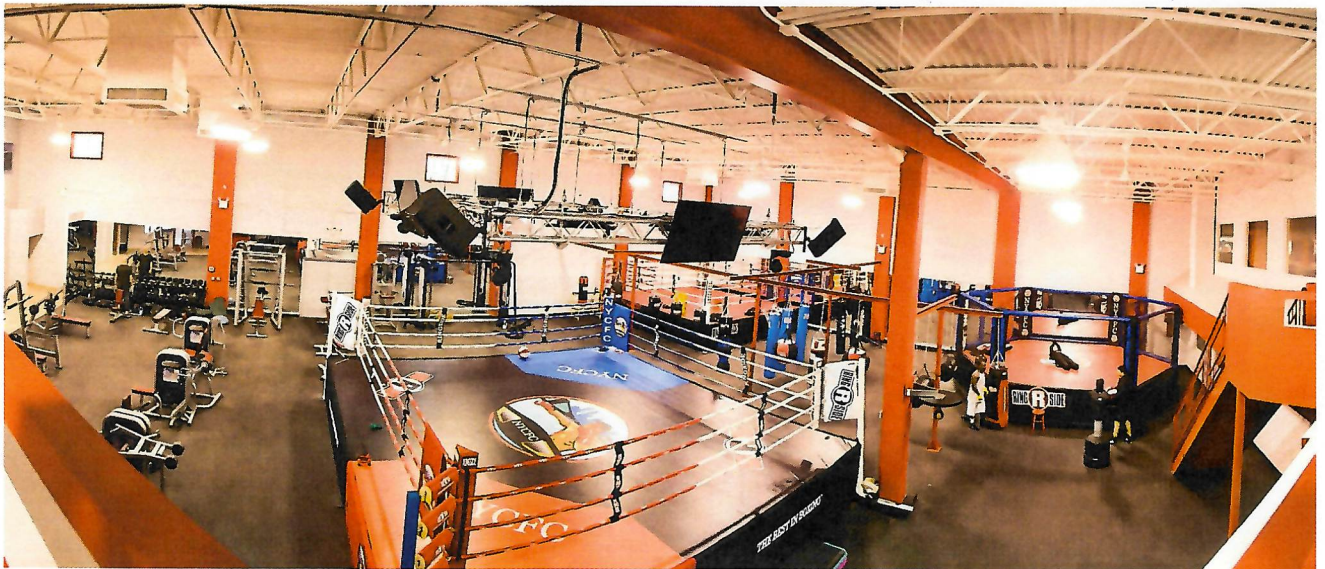

## 1. Aims and tasks

- continue to promote "MMA and Unifight" and geographic expansion of the participating countries;
- strengthening international sports relations and exchange of experiences between the national federations;
- identification of top athletes of "MMA and Unifight" in the World;

## 2. Organization, time and place of competition

The USMMAF and Unifight Open Championships is held from 29 to 31 of May, 2020 in 4930 20th Ave, Brooklyn, NY 11204, USA Sport hall "NYC Fitness Club".



### **The program of competitions:**

**May 29:** *certification and accreditation of the referees of the national federations to officiate matches in the championship - referee seminar will be held in which the referees who have passed the exam and received accreditation will be allowed to officiate at USMMAF and Unifight Open Championships. Referees who have not passed the seminar and the accreditation, refereeing USMMAF and Unifight Open Championships are not allowed.*

### **May 29:**

- arrival of teams, accommodation;
- 12.00 - 17.00 - Mandates Commission, weighing;
- 17.00-18.30 - official training on an obstacle course;
- 17.30-18.30 - Press Conference;
- 18.30-19.00 - a joint meeting of the organizing committee, referees and team leaders;
- the draw for the participants will be held by the Chief referee and the International board of Referees.

At the end of each competition day the meeting of the board of referees and the representatives of teams will be held.

### **May 30:**

- **10.00-14.00 - preliminary duels of Light, Unifight and MMA;**
- 14.00 – 15.30 – lunch
- 16.00 – 18.00 - preliminary duels of Light Unifight among men and women;
- 18.00 - opening ceremony of USMMAF and Unifight Open Championships;
- 19.00 – continuing of preliminary duels of Light Unifight .

### **May 31:**

- 10.00 - the beginning of final duels of unifight and MMA in all weight categories. Awarding of the winners and the champions of USMMAF and Unifight Open Championships is held after every 2 final duels, then the closing ceremony of the Championships. The athletes who will not be on the pedestal ceremony, who left without permission of the Chairman of the organizing committee, deprived of medals and prizes.

### **3. Administration of USMMAF and Unifight Open Championships:**

The general management of Championship is assigned to the Organizing Committee. The direct management of the competitions is held by referee board. Refereeing of Championship held in accordance with the Rules of Competition of "Unifight" approved by the Congress of USMMAF and AUF.

Chief Secretary of the Championship – by appointment.

### **4. Age groups of participants and weight categories:**

- 8-9 years old boys: 25, 28, 31, 35, 40kg
- 10-11 years old boys: 28, 31, 35, 40, 45, 45+kg
- 12-13 years old boys: 35, 40, 45, 50, 55, 55+kg
- 13-14 years old boys: 45, 50, 55, 60, 65, 70, 70+kg
- 15-16 years old boys: 55, 60, 65, 70, 75, 80, 80+kg
- 18 years and older men: 60, 65, 70, 75, 80, 85, 90, 95, 95 + kg
- 18 years and older women: 48, 52, 57, 63, 70, 78, and 78 + kg.

**Divisions:** Light, Unifight and MMA.

Uniform of athletes (Unifight): kimono red and blue gloves to hand combat with open toes with the logo «Unifight», boxing helmet with the logo «Unifight», shoes with soft soles without edges, shin guards and the rise of the foot, a protective shell, cap, sneakers to overcome the obstacle. Helmet and gloves should match the color of the kimono. Protective equipment should be under the kimono. For women, an additional special equipment for breasts.

Referee to serve the Open Championship caused by the decision of the Referee board of USMMAF and AUF.

Uniform of the referee: black pants, black shirt, soft sports shoes in black, black socks, red - blue sleeves.

Uniform of athletes (MMA): shin guards, cap, MMA shorts.

**There will be no walk-in Registration accepted!**

Each participant has to have a valid medical insurance, and present the insurance certificate to the Organizing Committee.

## **5. Competitions**

The procedure for the draw and order of matches is set (after the Credentials Committee and weighting) the board of referee based on the number of participants in each weight category.

Each athlete is required when passing the credentials committee to present an individual set of red and blue kimono, because each athlete will be assigned a unique number that will be sewn on the kimono.

## **6. Determination of Winners**

**The winner of the final combat takes the first prize, the one who lost - the second, the ones who lost the semi-final combats gets the third prizes. Places of the other sportsmen are identified according to the round in which they finished the competitions.**

**In a case of the circle system the winner and prize places will be raffle of the largest quantity of the victories, of the won rounds, of the least quantity of the penalty etc.**

## **7. Rewarding**

**Champions and winners will be awarded by medals, belts and diplomas.**

All teams must have two national flags and the national anthem on CD for the opening ceremony and closing ceremony.

Each national team must be in the form of their country.

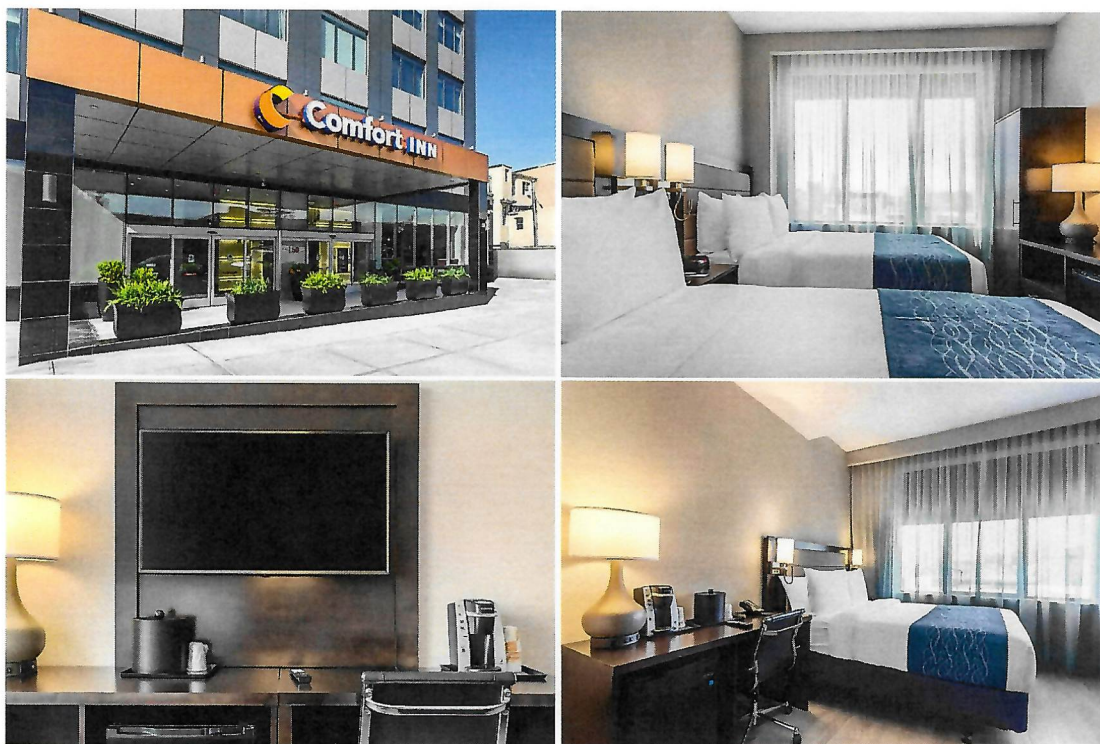
